





The links and information below offer advice, guidance and support that some schools may find useful and include information for teachers as well as resources to use with pupils. The information and resources listed will need to be examined for suitability and adapted for your own school or setting context. The list is not exhaustive and is intended to provide starting points for consideration. These resources have been put forward by a variety of education partners as part of the <u>Together for Humanity</u> campaign.

Association for Citizenship Teaching

The Association for Citizenship Teaching (ACT) is the subject association for everyone involved in Citizenship Education. ACT is a registered education charity and provides many free resources and professional development events as well as an extensive offer to schools and individual members. The association also publishes resources in the form of lessons and ready to use teaching materials and guidance on curriculum and pedagogy. ACT works to influence decision makers to provide better resources and supportive national policy for Citizenship across all phases of education. Resources include:

Teaching Controversial and Sensitive Issues

Two editions of ACT's journal *Teaching Citizenship* are available and include articles and teaching case studies:

<u>Prevent as A Controversial Issue</u> includes principles for addressing controversial issues and topics in the classroom and how to create a safe and open learning environment.

Discussion and deliberation

<u>The Deliberative Classroom</u> is a project to support teachers in leading knowledge-based discussions and debates with students on sensitive and controversial topical issues. The resources include:

- A general guidance booklet for teachers, with advice on leading knowledge-based debates on sensitive and topical issues, and links to curriculum subjects.
- A debate resource pack and a student resource pack on the topic of 'Religious Freedom'
 that includes a teacher topic briefing, and lessons.
- A debate resource pack and a student resource pack on the topic of '<u>Democracy</u>, <u>Protest</u> and <u>Change</u>' that includes a teacher topic briefing and lessons.
- Ten classroom activities to encourage democratic talk, including different kinds of debate, exploratory discussion, deliberation and simulation.

The lessons and activities in the resource packs and illustrated in the films are designed for key stage 3 pupils. They link to Citizenship, RE, History and English. <u>The Deliberative Classroom resources</u> were developed by ACT, Middlesex University and ESU and funded by the Department for Education.

Maintaining impartiality

Guidance on <u>Political Impartiality in Citizenship - a guide for Secondary Schools</u> was developed to support schools when teaching political issues, following the publication of the Department for Education <u>Political Impartiality Guidance</u>. The resource includes information on the law, how to maintain impartiality through teaching political and social issues, and a model school policy.

Curriculum models, lessons and schemes of work

ACT also offers a range of ready to use curriculum models, Citizenship lessons and pupils resources for key stage 3 and 4 including human rights, law, equality and diversity, teaching political and social issues, and developing local communities.

Facing History and Ourselves UK, use lessons of the past to create a better future. Through rigorous historical analysis combined with the study of human behaviour, Facing History's pedagogy is intended to develop understanding of racism, religious intolerance, and prejudice; increase students' ability to relate the lessons of history and literature to their own lives; and promote greater understanding of their roles and responsibilities in a democracy. The Red Cross International Humanitarian Law

The Red Cross offer resources to support <u>Teaching International Humanitarian Law</u> which is a requirement in the national curriculum for Citizenship. They also offer a series of resources called <u>Newsthink</u> which are designed to explore contemporary issues with pupils in upper primary and secondary education and include recent global conflict situations in the Middle East, Sudan, Afghanistan and Israel and Palestine.

Solutions Not Sides is an education programme that exists to provide humanising encounters, diverse narratives and critical-thinking tools in order to empower young people with the knowledge, empathy and skills to promote dialogue and conflict resolution, and to challenge prejudice in the UK. Its youth education program introduces Palestinian and Israeli peacebuilders directly in the classroom to share their personal stories and promote conflict resolution and peace building skills.

The Migration Museum

The Migration Museum offer an <u>online resource bank</u> which includes teaching resources to address migration, diversity, race and equality. The museum has an <u>outreach service</u> to work with schools to provide support.

Faith and Belief Forum

The Faith & Belief Forum have been working in schools for over 20 years, introducing students to lived experiences of faith and belief, building skills for dialogue, and developing students ability to respect diversity and build empathy. They have distilled their learning into a suite of online resources, with lesson plans, handouts and powerpoints for key stages 2-4, and sixth form. Its resources are mapped to topics in the RE, PSHE, and Citizenship curricula, and its methodologies and approaches can be used to support students to respectfully enter dialogue around controversial topics across every subject.
